An Act to apply a sum from the Consolidated Fund for the service of the year 2013 and to appropriate that sum for the service of that year.

ENACTED by the Parliament of Malaysia as follows:

Short title

1. This Act may be cited as the Supply Act 2013.

Issue and appropriation for the service of the year 2013

2. The issue of a sum not exceeding one hundred and sixty-two billion five hundred and forty-two million one hundred and ninety-seven thousand ringgit (RM162,542,197,000) from the Consolidated Fund for the service of the year 2013 is hereby authorised and that sum is appropriated for the purposes specified in the Schedule.
